### 1. Introduction

### 2. Eligibility

You must be at least 18 years old to use this Site. By using the Site, you represent and warrant that you meet this eligibility requirement.

### 3. Account Registration

To use our services, you must create an account. When registering, you agree to:

- Provide accurate and complete information.
- Keep your account credentials confidential.
- Notify us immediately of any unauthorized use of your account.

### 4. Betting Transactions

- Funds: This Site does not collect or hold any funds. You agree that all accepted bets will be paid outside of this Site. This Site does not facilitate any payments between members.

### 5. Betting Rules

- All bets must comply with the rules established for each event.
- You are responsible for understanding the rules and outcomes of the bets you participate in.
- Disputes regarding bets will be handled in accordance with our dispute resolution procedures outlined in these Terms.

### 6. Fees and Charges

- This Site does not charge any fees or juice on wagers.
- Drop The Book, LLC is a members only platform. You must have an active membership to engage in any wagers between members.
- This Site charges a monthly fee of \$9.99 + tax per month for membership dues.

### 7. User Conduct

By using the Site, you agree not to:

- Engage in fraudulent or dishonest behavior.
- Attempt to manipulate or disrupt the betting process.
- Use automated systems or scripts to access the Site.
- Violate any applicable laws or regulations.

### 8. Termination

We reserve the right to suspend or terminate your account at our discretion if we suspect any violation of these Terms, fraud, or illegal activity.
